1. Background

- 1.1 Devon and Cornwall Police was placed into the "engage" phase of monitoring by His Majesty's Inspectorate of Constabulary and Fire & Rescue Service (HMICFRs) in Autumn 2022. A new Chief Constable, Mr Will Kerr OBE was appointed in December 2022. Mr Kerr was suspended in July 2023 following criminal allegations being investigated by The Police Service Northern Ireland (PSNI). Criminal investigation has now concluded with an indication that no criminal charges will be progressed.
- 1.2 There is an investigation by the Independent Office for Police Conduct (IOPC) relating to Mr. Kerr, for potential gross misconduct, although it is not directly related to the criminal allegations investigated by PSNI.
- 1.3 The investigations to date have been underway since early 2023 and although criminal matters are now not being pursued, the IOPC investigation continues. Mr Kerr has remained suspended on full pay since July 2023 as per the requirements of police regulations.

2. Decision Record

- 2.1 A mutually agreed retirement between the Commissioner and Mr Kerr was made effective on 25th July 2025.
- 2.2 The decision was made in order to move forward with processes to allow new and stable leadership for Devon and Cornwall Police after a significant period of uncertainty.

3. Consultation, Engagement and Communication

3.1 Key stakeholders were consulted on this decision to agree Mr Kerr's retirement. These included the Chief Inspector of His Majesty's Inspectorate of Constabulary and Fire and Rescue Service (HMICFRS), the College of Policing and the Independent Office for Police Conduct (IOPC).



4. OPCC Monitoring Officer advice

4.1 Legal, Management, Equality and GDPR Implications – Current and Future

- a. The PCC's Chief Executive and Monitoring Officer has advised that the arrangements set out in the proposal meet the requirements of the relevant legislation and the needs of the organisation.
- b. The PCC's Chief Executive and Monitoring Officer is satisfied that the Police and Crime Commissioner has taken into consideration a wide range of factors in making her decision to agree to Mr. Kerrs retirement. These factors include but are not limited to the following matters: the two-year anniversary of the suspension with an outstanding IOPC investigation(with no certainty as to when that investigation will conclude); that Mr Kerr has not been charged with any offences or found guilty of any criminal matters; avoiding any future costs of Mr. Kerrs suspension continuing indefinitely whilst on full pay; ongoing costs of paying more than one Chief Constable; ongoing legal costs; settlement costs; and the need for stable and experienced leadership of Devon and Cornwall Police after such a long and uncertain period of leadership at the most senior rank in the Force.
- c. The PCC's Chief Executive and Monitoring Officer is clear that there is no certainty on the length of time that the ongoing IOPC investigation will take, and any sequencing of subsequent hearings (if they are indeed necessary). Both matters are outside of the Police and Crime Commissioners control and are a risk to the ongoing stability of Devon and Cornwall Police. Significant delays, as may be anticipated, would result also in significant additional cost.
- d. The PCC's CEO and Monitoring Officer has advised that this decision is within the powers of those making it and that, from the information provided, there would not appear to be any adverse legal, managerial, equality or GDPR implications arising from the proposal.

4.2 Financial and Commercial – Current and Future

The financial impact of this decision equates to a settlement equivalent to 9 months pay (£165,539). In addition, all contractual payments will be made at the point of leaving Devon and Cornwall Police.
