Commissioner's covering note

The role of Police and Crime Commissioner was created to help make the police more accountable to the people they serve, and the holding of our local police to account on behalf of the people of Devon, Cornwall and the Isles of Scilly is my core responsibility.

I do this in a number of ways, one of them via my Commissioner's Accountability Board that I introduced earlier this year. Through this Board, I select a number of areas of policing activity and related performance, and as Chair, scrutinise them in detail, requiring the Chief Constable and his team to explain both current performance, and any plans they have in place to make improvements where required.

Following this, I then make a judgment on how assured I am, again both in terms of current police performance and the quality of any improvement plans. I then publish a statement describing my levels of assurance for the public to see, along with the agenda and attendance at each Board, to ensure as wide a visibility as is possible.

I remain committed to ensuring that Devon and Cornwall Police delivers a service to our communities as effectively and efficiently as is possible, and my office and I will continue to not only scrutinise and challenge robustly, but also to celebrate and champion whenever appropriate, on behalf of the people of Devon, Cornwall and the Isles of Scilly.

Statement of assurance

Within this meeting the Commissioner explored three areas of Devon and Cornwall Police's performance for the purposes of assurance. These included:

- Devon and Cornwall Police's response to HMICFRS' Integrity Inspection
- Review of the Chief Constable's budget proposals
- Corporate Code of Governance

| 1 | Devon and Cornwall Police's response to HMICFRS' Integrity Inspection | In March 2025, His Majesty's Inspectorate of the Constabulary and Fire and Rescue Services (HMICFS) undertook an inspection into integrity arrangements of Devon and Cornwall Police. The inspectorate found that improvement was required in the police's handling of complaints, misconduct, vetting, and counter-corruption. Following a presentation to the Board, the Commissioner was part assured by Devon and Cornwall Police's performance in this area. The Commissioner noted that progress had been made since HMICFRS' inspection: The police had reduced their complaint backlog from 1,600, to 410. The time taken for the police to log complaints had reduced from approximately 61 working days, to around 2 weeks. The number of business interests awaiting assessment had decreased from 800, to 10. However, the Commissioner recognised that some areas of performance could still be strengthened, particularly in relation to the proactive monitoring of encrypted devices, and the police's oversight of complaints outside of the Professional Standards Department. The Commissioner was assured of Devon and Cornwall Police's plans to continue improvement in this area. This included provision of a new IT system to improve management of complaints and continued plans to implement the new Police (Vetting) Regulations 2025. | Part Assured | Assured |

| 2 | Chief Constables budget proposals | The Commissioner is assured by the Chief Constable's continued delivery of the 2025/26 budget, noting that most commitments are on track to be achieved by the end of the financial year. The Commissioner was assured by the Chief Constable's plans for the 2026/27 budget. Whilst budget proposals were in draft format, awaiting confirmation of the police settlement, the Commissioner supported plans to retain numbers of frontline police officers, maintain resilience in crime investigations, and improve technology. | Assured | Assured |
