This includes the young men who have experienced or witnessed domestic violence or at risk of entering it.

### 1. Background

1. A Band of Brothers (ABOB) is a Cornwall based organisation which supports young men aged 18 to 25 who are involved in, or at risk of entering, the criminal justice system. Through a structured rites-of-passage programme and long-term mentoring, the project helps participants build emotional resilience, find meaning and purpose, and to connect with their communities.
2. The project addresses urgent needs in Cornwall linked to trauma, isolation, and cycles of offending among young men. Many participants have histories of abuse, neglect, and exposure to substance misuse. ABOB provides them with a trusted network and structured support to build healthier relationships, manage anger, reduce violent behaviour, and take steps into education or employment, transforming their lives.
3. The programme is expected to significantly improve mental wellbeing, reduce reoffending, and increase community safety. In 2024, 90% of ABOB participants said they'd reduced their offending behaviour and 99% reported increased levels of hope, motivation and possibility for their lives. The wider impact includes stronger community ties and reduced burden on public services.
4. Implementation timeline:
  - 1<sup>st</sup> November 2025 – 31<sup>st</sup> May 2026.



## 2. Decision Record


