### **1. Context**

1. To utilise the grant funding to provide crucial, tailored specialist support built on lived experiences to third-party victims of crime across Devon, Cornwall, and the Isles of Scilly. This includes the parents, carers, partners, siblings, and loved ones of individuals who have survived sexual abuse, sexual violence, or other serious violent crimes, including domestic abuse.
2. Offer training to organisations, businesses and particularly those agencies that count victims of crime and their families amongst their service users. Training is delivered by 3rd party victims of crime with lived experience of caring for someone who is a survivor of a serious sexual or violent crime.
3. Implementation timeline:
  - 1<sup>st</sup> April 2025 – 31<sup>st</sup> March 2026.

### **2. Decision Record**

- 2.1 To issue a 12-month grant to Restitute to support third-party victims of crime across Devon, Cornwall, and the Isles of Scilly. This includes the parents, carers, partners, siblings, and loved ones of individuals who have survived sexual abuse, sexual violence, or other serious violent crimes, including domestic abuse


